Mother of victim glad ordeal finally over

An attorney for the victim of the Al Hahn molestation case released a statement from the mother of the victim to the Madera Tribune following the settlement in the civil suit against Madera County and the Board of Supervisors.

In that settlement, the boy received \$350,000 from the county, \$250,000 of which was paid for by an insurance policy.

Hahn had been sentenced to 26 years in prison in 1994 after being convicted of 28 counts of molestation.

The boy, molested by Hahn, sued the two found guilty and convicted for. parties claiming they had hired someone who

properly supervise him.

The county argued that Hahn had a good reputation when hired and that they didn't know about his molestations.

The mother's statement was released through their attorney James Chanin, who did so with the stipulation that the boy not be identified. It

"First, I would like to say that we are relieved this case is finally over. It has been a long, hard, three years for us. My son was tormented and humiliated on a daily basis at school and even at church for coming forward dren. and charging Al Hahn for the crimes he was

"After one and a half years of hell, we had to

Madera in order for my children to be safe, they have learned a valuable lesson on how to away from Al Hahn and his family members and friends who regularly detoured through our neighborhood. We have sacrificed enough.

"I feel that Madera County owes my son an apology for their treatment of him, when they should have been thanking him for coming forward and saving their children from falling victim to Al. If it wasn't for my son, Al would still be using his position to gain the trust of his victims and their families, which would've allowed him to continue molesting our chil-

"I also feel that the Madera County government should publicly apologize to the victims for turning a blind eye and allowing this to hap- er Beryl Ravisconi and comprehensive counwas incompetent for the job and then didn't leave our home and the friends we had made in pen as long as it did in the first place. I hope
